1. SPECIFIC SUPPORT FOR CRIMINAL JUSTICE REFORMS

1.1. Innovation Projects:

ENTRY No. 01/10

Support for Innovations in Criminal Procedure

Objectives:

To promote the adoption of ideas and instruments that have been developed to improve the operation of reformed criminal justice systems by the countries of the region. These activities are implemented at the request of the nations involved and generally come about as the result of local replicas of the Training Program. The support activities are very diverse depending on the nature and state of the processes. They generally involve training activities, support for design and supervisory efforts and, in more general terms, political support for the process.

Location(s):

- <u>Córdoba, Argentina.</u> This province introduced a criminal justice reform process in 1998 but did not introduce oral procedures at pretrial stages, which has caused problems in the operation of the system. In July 2010, the judicial system issued an order to move forward with a pilot project in the jurisdiction of San Francisco.
- <u>Santa Fe, Argentina.</u> This, the country's third most important province, launched a complete and radical criminal justice reform in 2009 which is to be implemented gradually.

Funding source: CIDA.

Impact or results:

In the context of the collaboration agreement signed with Santa Fe's Executive Branch in order to support the above-mentioned process, JSCA continued to provide technical support through the monitoring and support of activities and the training of justice system actors. JSCA's Executive Director participated in the selection of candidates for Prosecutor General and Public Defender General in the province and was a member of the public examination process for said candidates. This was the first time that said process was implemented in the province.

Regarding the <u>Córdoba Province Pilot Project</u> (Argentina). During this period, JSCA has worked with local officials to implement a plan to modernize the criminal procedure system by creating an oral hearing system for the investigation stage. It is important to note that Córdoba Province is the second most-populated province in Argentina and has a great deal of influence in the rest of the country and Latin America.

JSCA participated in the working session held August 2 and 3 in order to design the pilot project and supported the process of training local actors during a workshop held September 13 and 14 that was attended by nearly 50 justice system operators.

The pilot project began on September 27, and JSCA plans to monitor and evaluate it. Local authorities have committed to expand the project to the city of Córdoba during the first quarter of 2011.



1.2. Research

ENTRY No. 2/10

Study on Pretrial Detention in Latin America

Objectives:

To continue to identify key aspects to be addressed in the rationalization of the use of pretrial detention in the region in order to set an agenda in this area. Studies will be added to those that have already been implemented (Bolivia, Chile, Colombia, Ecuador, Guatemala, Honduras and Venezuela). This year new studies have focused on countries with federal government systems such as Mexico, Brazil and Argentina. A study of Peru was conducted as well.

Judicial Systems Journal:

The new virtual version of Judicial Systems Journal was launched in April. The first issue focused on pretrial detention, featuring articles such as "Pretrial Detention in Latin America: Early Sentences, Protective Logic and Counter-Reform (*Régimen de prisión preventiva en América Latina: la pena anticipada, la lógica cautelar y la contrarreforma*)" and "The New Agenda of Discussion of Pretrial Detention (*Nueva Agenda de discusión sobre la Prisión Preventiva*," (authored by Cristián Riego, Executive Director of JSCA). The publication also included articles that provided a broader vision of the issue through the experiences of various countries in the region, including "Risk Evaluation Services and Supervision as Mechanisms for Managing Alternatives to Pretrial Detention (Servicios de evaluación de riesgos y supervisión como mecanismos para el manejo de las medidas cautelares)"; "Pretrial Services as a Means of Reducing Pretrial Detention Rates in the Region (Servicios de antelación al juicio como una alternativa para disminuir los índices de prisión preventiva en la región," which was based on the observation of two pretrial services programs in Washington, D.C.) and "The Bail System and Pretrial Detention in Canada (Sistema de libertad bajo fianza y prisión preventiva en Canadá)." The publication also includes a report on the costs of pretrial detention in Chile that was authored Fundación Paz Ciudadana experts and members.

Workshops:

In regard to the reports that are being developed now and in order to coordinate the research team, which is composed of a diverse group of consultants, a workshop was held in Buenos Aires on September 22 to review the first drafts of the four country studies and discuss research methodologies in order to improve the final versions. Representatives of Open Society Justice Initiative were invited to the event.

Impact or Results:

<u>Opportunities for discussion</u> were developed in several countries, and each event was led by JSCA. Activities focused on presenting country reports were held, including:

A seminar on the situation of pretrial detention in Central America was held in Costa Rica on January 26. The event featured a presentation on the work done by local researchers in Costa Rica, El Salvador, Guatemala and Honduras. The Supreme Court Chief Justice and Minister of Justice of Costa Rica attended the event and offered reflections on his country's future in this area.



On January 28, a roundtable discussion entitled "Regional Experience with Pretrial Detention in the Context of Mexico's Criminal Procedure Reform" was held in Mexico City. The event featured the participation of a wide range of officials who discussed pretrial detention in that country and future areas of work. The meeting was organized by the Mexico City Human Rights Commission, JSCA, Open Society Justice Initiative, Institución Renace, A.B.P. and the Institute for Security and Democracy (INSyDE).

The Seminar "Pretrial Detention: The Situation of Ecuador and Latin America" was held on April 22 in Quito, Ecuador. The event, which was attended by 400 people, was organized in collaboration with the country's Public Defender's Office. It was designed to present the current state of pretrial detention in Ecuador, in Latin America and in comparison with Colombia.

The seminar "The State of Pretrial Detention in Guatemala" was held in Guatemala City on June 16. The event, which was quite well-attended, included the presentation of local results of the research project and a regional perspective.

A cycle of presentations was developed and implemented during the second half of the year in order to present the results of the Peru Report. The events were implemented in Lima, Piura, Chiclayo, Cusco, Trujillo, Arequipa and Tacna.

Finally, on November 1, JSCA's Executive Director presented the institution's assessment and public policy vision of pretrial detention to the Inter-American Commission on Human Rights.

Current activities:

The final versions of the reports developed this year will be ready in April 2011, and a new publication will be prepared for mid-2011. We will continue to disseminate and discuss the results of these actions over the course of the next year.

ENTRY No. 03/10

The Criminal Justice System and Crimes with Social Impacts

Objectives

To explore and evaluate the current capacities of the region's criminal justice systems to investigate, prosecute and punish crimes, particularly those that have the greatest impact on public opinion and among the population.

Coverage:

Argentina, Colombia, Chile, Perú, Venezuela and Mexico

Funding sources:

The Government of Italy and the Office of the Undersecretary of Public Affairs of the Organization of American States (OAS)

Products:

The final versions of the local reports on Argentina, Chile, Colombia, Mexico, Perú and Venezuela were finalized in 2010 along with a comparative report. Over the course of the year, the results were presented in the countries that had completed reports in order to discuss the results with local stakeholders and explore possible future actions.

Dissemination:

A seminar entitled "Current Challenges for the Public Prosecutor's Office" was held in July in collaboration with Chile's National Public Prosecutor's Office and Fundación Paz Ciudadana. The



event was sponsored by the Ministry of Justice and the Ministry of the Interior's Public Safety Division.

Print publication:

All of the reports were included in a book entitled **Challenges to Criminal Prosecution and Investigation in the Americas,** a Spanish-language publication that will be made available in November 2010. It will be published online, and print copies will be distributed to the regional community during presentations and discussions that are to be held in 2011.

Judicial Systems Journal:

Abstracts of the Argentina, Chile and Colombia reports were included in the issue of *Judicial Systems Journal* that will be available online in November. The material will include audio recordings of interviews with key stakeholders regarding this issue.

Other:

Interviews with the Argentina report's author and the project coordinator were turned into a podcast (the interviews were conducted via Skype and recorded in radio program format). This will allow JSCA to disseminate the project contents to the region through the Internet.

Impact:

The seminar on this topic that was held in Chile was attended by 70 people and involved institutions related to the issue, allowing for a discussion of problematic aspects of criminal prosecution and challenges to be faced in regard to the prosecution of both common crimes and those with high social connotation.

JSCA's Executive Director also took part in activities in Mexico and Argentina that made mention of the report results.

The podcasts generated a great deal of interest in the community and the audio material was downloaded by many users.

ENTRY No. 04/10

Follow-up Study on Criminal Procedure Reform: Research, Publications and Dissemination

Objectives

To explore the results and impact of the region's criminal procedure reforms. These studies form part of a group of research projects that JSCA has conducted in 14 countries in the region in an effort to generate empirical data on the achievements realized and obstacles faced.

Locations:

The Mexican States of Mexico, Chihuahua, Oaxaca, Zacatecas and Morelos

Funding source:

USAID-MSIMEX: Mexico

Products:

This study is being developed in five Mexican states (Mexico, Chihuahua, Oaxaca, Zacatecas and Morelos) that have implemented a criminal procedure reform. The objectives of this effort include collaborating with states that had initiated processes designed to improve the operation of the new system and contributing to states that are planning new reforms so that they can consider the achievements and problems encountered by those that have already done so.



This study has required JSCA's technical team to travel in order to transfer and confirm the methodology of the study for the 10 Mexican researchers who are gathering information.

A workshop for researchers was held April 29 and 30. Its focus was JSCA's methodology for followup studies. It was run by JSCA Program Director Mauricio Duce and Academic Coordinator Leticia Lorenzo.

JSCA is awaiting the submission of the final reports and planning validation workshops.

Impact:

The reports submitted are under review and we expect them to be finalized during the first half of 2011. They will be published once the study is completed.

ENTRY No. 05/10

Study on the Empirical Operation of Alternatives to Pretrial Detention in Chile

Objectives:

To explore the empirical operation of the alternatives to pretrial detention provided for in Article 155 in Chile's Criminal Procedure Code. The report is being developed in collaboration with Fundación Paz Ciudadana and a professional sociologist.

Coverage:

Chile

Funding source:

Open Society Justice Institute

Products:

The methodology and tool for gathering quantitative data on the use and impact of alternatives to pretrial detention is being developed. The researchers are compiling available data on the context as well as statistics on the topic.

The report will include interviews with local justice system operators and a comparison of the procedural path of cases in which pretrial detention, the measures provided for in Article 155 of the Criminal Procedure Code and both are utilized in order to develop conclusions on the use of certain measures in relation to the outcome of the case.

Impact:

A document describing the use and effectiveness of measures other than pretrial detention in the Chilean context will be developed. The final report will be submitted in January 2011.

ENTRY No. 06/10

Document Development for the Creation of a Risk and Supervision Evaluation System for Alternatives to Pretrial Detention in Chile

Objectives:

To develop base documents for the proposal of a system for overseeing alternatives to pretrial detention that involves the evaluation of the risk and supervision of the application of such mechanisms in order to optimize their use.

Coverage:

Chile



Local counterpart:

The Public Safety Division of Chile's Ministry of the Interior

Funding source:

Open Society Justice Initiative

Products:

Proposal presented to and approved by the Public Safety Division.

Technical collaboration agreement to be signed by the two institutions in late 2010.

Impact:

Mutual Collaboration Agreement:

A technical collaboration agreement will be signed with the Public Safety Division during November 2010 as part of this project.

Specific Reports

The project involves the submission of four specific reports including: a review of comparative experiences in the implementation of risk assessment offices; a local report on the experiences of Chile; a report on costs; and systematization of existing data related to alternative measures.

Projection:

Once the project is finished (after approximately six months), JSCA will take part in a roundtable discussion designed coordinate various judicial system and government actors in order to establish the methodological design and final organization of the project.

ENTRY No. 07/10

Research on the Implementation of a Hearing Management Model in Guatemala

Objectives:

To gather information on the current operation of the hearing management model in the *departamentos* in which it has been implemented in Guatemala; to analyze the results produced over the nearly five years that have passed since its implementation; and to present the challenges that have been identified in this area of the organization of criminal justice for the coming years.

Coverage:

Guatemala

Funding source:

Products:

Based on the visits carried out over the past year in Quetzaltenango, Huehuetenango, Sololá, Cobán, Chiquimula, Zacapa and Guatemala City to observe the operation of the criminal justice system, a final report was submitted during the first half of 2010 on the implementation of oral preliminary hearings and the design of innovative management systems in an effort to overcome the problems identified.

Impact:

Publication and Dissemination:

The report was published and printed in September 2010 in the book "Reformas de la Justicia en América Latina: Experiencias de Innovación," (Spanish language publication entitled *Justice Reforms in Latin America: Experiences in Innovation*), which contains a series of reports on innovation in the area of criminal justice and other areas in Latin America (see Publications section).

ENTRY No. 08/10

Research on the Implementation of the Judicial Administration Management Model in Trelew and Esquel

Objectives:



To gather data on the implementation of a new judicial administration management model based on the experiences of the judicial offices of Trelew and Esquel.

Coverage:

Publication and Dissemination:

1.3. Training

ENTRY No. 09/10

VII Inter-American Program for Training Trainers for Criminal Procedure Reform

Objectives:

To improve the results of criminal justice reform processes in the region by training key actors and leaders and implementing replicas of the program in their countries. The Program consists of an on site basic course; an e-learning course offered through CEJACAMPUS; and an on site advanced course.

Coverage:

The first phase, "Instruments for Implementing an Oral and Adversarial System," was held May 3-7, 2010. The e-learning stage, "Problems in the Implementation of Criminal Procedure Reform," ran May 17 through October 24. Finally, the advanced course, "Litigation Skills for an Oral System," will take place November 22-6 in Santiago de Chile.

Program training materials

Two on site courses (stages 1 and 3) and the execution of stage 2 via Internet

Improvement of the CEJACAMPUS Website through the conversion of the platform to DOKEOS.

Impact:

Program Stages and Attendance:

The Program was very well-received in the region. A total of 280 individuals from 14 countries applied, and 51 participants from various American nations were selected to attend the courses. The following countries were represented: Argentina, Bolivia, Chile, Colombia, Costa Rica, the Dominican Republic, Ecuador, Guatemala, Honduras, Mexico, Nicaragua, Panama, Peru and Venezuela.

A total of 52 people took part in the advanced course, 49 of whom had completed stages 1 and 2, and 3 of whom were students from the previous year who had not yet completed the advanced course.

Once the first three stages are complete, students will develop replicas in their home countries. Information on the replicas will be included in the next report.



ENTRY No. 10/10

IV Inter-American Meeting: Alumni Network of the Inter-American Program for Training Trainers for Criminal Procedure Reform

Objectives:

To promote the Program's Alumni Network in order to broaden members' knowledge of topics linked to innovative initiatives in regional reform processes and to strengthen collaboration in the network.

Coverage:

The meeting is to be held on November 10 in Santiago, Chile

Funding source:

CIDA

Products:

The meeting is part of the International Conference Celebrating the 10th Anniversary of Chile's Criminal Procedure Reform, which was developed by the Universidad Diego Portales Law School's Criminal Procedure Reform and Litigation Program with the support of JSCA.

The Network activity includes the presentation of a methodology as part of a panel discussion entitled "Experiences in Risk Assessment and Supervision in the Use of Protective Measures in Criminal Procedure." The discussion is to be led by JSCA Executive Director Cristián Riego; Javier Carrasco, Project Manager of the Presumption of Innocence in Mexico Project of the Open Society Justice Initiative; Francisco Rojas, Assistant Chief Prosecutor for the Office of Domestic Violence and Sex Crimes in the Southern Metropolitan Region Prosecutor's Office; and Alberto Binder.

Impact:

The activity was attended by 49 Alumni Network members from Argentina, Bolivia, Chile, Colombia, Costa Rica, Ecuador, Guatemala, Honduras, Mexico, Panama, Peru, Uruguay and Venezuela.

ENTRY No. 11/10

Alumni Network Activities

Objectives:

To promote the Alumni Network in order to expand members' knowledge of the implementation of innovative initiatives in regional reform processes and increase collaboration among network members.

Coverage:

Regional

Funding source: CIDA

Specific activities:

After the National Redex Meeting held in Argentina in 2009, a publication was launched simultaneously in several provinces during the first semester of 2010 (Santiago del Estero, Tucuman, Catamarca). This publication came as part of a series of activities that were held throughout the country in late 2009. The book on the first Redex meeting in Argentina and the presentations offered during the event can be accessed online at www.cejamericas.org.

The II National Meeting of Criminal Procedure Reform Trainers of Argentina was held October 14 and 15 in Formosa. It was sponsored by the province's Superior Court and featured the participation of 15 network members and JSCA Program Director Mauricio Duce.

Impact:

Local alumni groups have maintained virtual exchanges through the Cejacampus Web platform.

National alumni groups have continued to organize activities to be held in 2011.

A book containing the papers presented at the II Redex National Meeting in Argentina will be published at the end of this year.



ENTRY No. 12/10

Training Course: "Challenges and Opportunities in the Assessment of Evidence During Adversarial Oral Trials"

Objectives:

To show the complexities of and possibilities opened by the assessment of evidence in adversarial oral systems so as to improve the quality of judicial decisions.

To introduce a methodology that allows judges to improve their capacities and skills in the handling and assessment of specific types of evidence.

Coverage:

The course was held September 2 and 3 in Santiago de Chile.

Funding source:

CIDA

Products:

The training program was developed with the support of Canada's National Judicial Institute and featured the participation of NJI and JSCA academics. Training materials consisted of exercises and video recordings that can be used in course replicas.

Impact:

The course was directed at judicial trainers from the member organizations of the Ibero-American Network of Judicial Academies (RIAEJ) and trainers who work with JSCA. There were 37 participants including judges and judicial trainers from Argentina (9), Brazil (2), Chile (14), Costa Rica (2), Honduras (1), Peru (5), Puerto Rico (2), the Dominican Republic (1) and Uruguay (1).

ENTRY No. 13/10

Virtual Course "Introduction to Gender Issues in Criminal Justice in Latin America"

Objectives:

To incorporate the gender variable into the processes of discussing, designing and implementing judicial reforms through an e-learning course.

Coverage:

This is an e-learning course.

Funding source:

CIDA

Products

The course ran from July 5 through August 29. For more information, see www.cejacampus.org.

Impact:

Response:

A total of 24 people from 11 countries enrolled in the course.

Publication:

We published a manual for the virtual course in June 2010. The text, which has the same title as the course, was edited by Lidia Casas. Two hundred print copies have been distributed and the text has been made available on the JSCA Website.

ENTRY N 14/10

Virtual Course "Challenges to the Public Prosecutor's Office in Latin America 2010"

Objectives:

The purpose of this program is to present an introduction to the current state of public prosecutor's



offices in the region and the main challenges that said institutions must face in the context of the introduction of adversarial criminal procedure systems as a result of the criminal procedure reform.

This activity was an e-learning course.

Impact:

Response: A total of 35 students from 11 countries in the region enrolled in the course.

ENTRY No. 15/10

Development of the Virtual Course "Pretrial Detention in Latin America"

Objectives:

This training program will include an overview of the use of pretrial detention in the region and challenges to consider in a regional discussion. It will include an empirical and normative assessment of pretrial detention in Latin America; international standards for its application and use; elements of the discussion of the use of pretrial custody; and information on pretrial services in the United States, which are designed to promote the use of alternative measures.

This activity was an e-learning course.

Funding source:

Products:

The manual for this course has been finalized and training modules are being compiled for the Cejacampus virtual platform.

Impact:

This course will be offered next year.

ENTRY No. 16/10

Virtual Course on "Drug Treatment Courts"

Objectives:

This course is designed to review the reaches and components of drug treatment courts as an innovative approach to the issue of the effects of drug additions. Participants will review the progress that has been made, contemporary research and theories based on these programs. The purpose of the program is to allow judges, prosecutors, public defenders and members of psychosocial teams learn about these aspects and apply them to their daily work.

Coverage:

This course is offered using the e-learning methodology.

Products:

The course is mainly based on the "Drug Treatment Courts in Chile" documents developed by Fundación Paz Ciudadana in 2010 and benefitted from the collaboration of Chilean academics and criminal justice system operators. The materials have been adapted to the reality of Latin America.

Impact:

The course will be offered next year.



ENTRY No. 17/10

Internships in Canada

Objectives:

To allow a group of training program alumni to learn about the Canadian justice system and the organization and functioning of the prosecution service through direct work experience.

Coverage:

Public Prosecution Service, National Judicial Institute and Ontario Province Prosecution Service

Funding source:

Products:

This year, seven members of the Alumni Network completed three to five-week internships. The first program ran from May 3 through 21 and was completed by Guillermo Nicora (Argentina) and Fábio Gusman (Brazil), who visited the Public Prosecution Services of Ottawa and Montreal.

Claudia Barcia (Argentina), Rosaly Ledesma (Bolivia) and Ximena Vintimilla (Ecuador) visited the Crown Attorney Offices in Ontario during June (the exact dates were June 7 through 25, 2010).

Claudio Fuentes (Chile) completed a one-week internship (July 4-8) that involved attending the National Judicial Institute's "Evidence Workshop" in Québec.

Finally, Ramón García of Chile attended the "Preventing Wrongful Convictions" course at the National Judicial Institute in St. John's Newfoundland during one week in late October.

Impact:

Interns generated reports on what they learned, which will be published on our Website.

Internships on Pretrial Detention in the United States

Objectives:

To allow a group of professionals linked to JSCA's work in the area learn through direct work experience about pretrial services, which have been created to provide quality technical information to the parties and judges who make decisions about release conditions for those caught committing a crime.

Products:

During the last week of November, a delegation composed of JSCA Research Coordinator Leticia Lorenzo and two representatives of the Ministry of Justice and Ministry of the Interior of Chile will conduct a research visit to the Pretrial Justice Institute in Washington D.C. The institution offers pretrial services at the federal level and supports the management of protective measures through risk assessment and supervision programs.



Impact:

The professionals who participate in this internship will draft reports on what they learn.

ENTRY No. 19/10

Visits/ Workshops on Criminal Justice in Chile

Objectives: To allow foreign delegations to learn about the development of Chile's criminal procedure reform and its logics and dynamics in terms of judicial matters and administration, implementation and management. This will be developed through guided visits that will feature oral hearing and administrative procedure observations and meetings with JSCA staff and others.

Study of the Use of Oral Procedures in Areas Other Than Criminal Justice

The 2010 Index compares this year's results with those of 2004, 2006, 2007, 2008 and 2009, which are presented in earlier studies developed by JSCA. This publication also analyzes the type of information that judicial systems offer online at the hemispheric level.

The 2010 edition will be presented at the VIII International Seminar on Judicial Management in Brasilia in late November. JSCA also will have an informational stand in place throughout the event.

Effective Justice: The Role of New Technologies in the Transformation of the Judicial System

Objectives:

To produce a locally validated assessment of 26 Inter-American Development Bank beneficiaries with special emphasis on the levels of and opportunities for inter-institutional coordination for select judicial processes and challenges regarding access to information and judicial services.

Preparatory work for the Action-Learning Program on Judicial Transparency and Accountability in LCR. Development of contents and facilitation of the program's execution.

The Impact of Information Technologies on Access to Judicial Information and Justice

Objectives:

To improve the transfer, collaboration and dissemination of the role of ICTs among the region's judicial institutions, generating an instrument for measuring access to information and justice.

Products:

Identification of best regional and international practices regarding the use of ICTs

Development of an e-justice model

Development of an index for measuring the level of access to justice (pilot program in Chile to be expanded to four countries in the region following a selection process)

The results portion will be complemented by an analysis developed by JSCA to measure access to judicial information. ICT service measurement mechanisms will be installed to determine the level of e-justice available in the region's judicial institutions. The competitive effect that the ranking process will generate should lead countries/institutions to improve their technological platforms and expand services to more groups, particularly at-risk sectors. The results will be presented in 2011.

Virtual Course on Managing Criminal Justice System Agencies

Objectives:

To provide participants with a comprehensive overview of the management of criminal justice system agencies in an adversarial context and with tools for assessing and implementing plans that reflect the concepts discussed.

VIII International Seminar on Judicial Management "Strategic and Technological Planning for Today's Caseload"

Objective:

To explore and discuss strategic and technological planning for judicial branches at the intra- or interinstitutional level, identifying accumulated experiences and specific best practices related to the procedural sphere and the implementation of ICTs.

To ascertain how these two variables can be particularly useful for the analysis and adoption of measures for confronting class action lawsuits while protecting citizens' fundamental rights.

The three panels will discuss: strategic planning in Supreme Courts; strategic planning for today's caseload volumes; and ICTs at the service of justice administration.

Innovative experiences in management from various areas will be presented as well.

Impact:

Some four thousand people are expected to attend the event in representation of several countries, including high-ranking judicial officials. Various media outlets will cover the seminar.

Pro Bono Internships

Objectives:

To enrich JSCA's work through the new approaches provided by interns and to create lasting links with former interns in order to establish contact with local experts and institutions. These positions are mainly directed at students or recent graduates and provide an opportunity to understand and take part in JSCA's work on judicial reform in Latin America.

Products:

JSCA received **10 pro bono interns** from three countries in 2010.

Mary Roberts of the University of Toronto and Jessica Horwitz of Queen's University, Ontario, Canada, worked on JSCA Management Area projects in May and June. The initiatives that they worked on include "Effective Justice: The Role of New Technologies in Transforming the Judicial System," which was developed at the request of the Inter-American Development Bank and the Action-Learning Program on Judicial Transparency and Accountability in LCR, focusing their efforts on justice service perception surveys in Chile. Jessica also contributed to the project on "The Impact of Information Technologies on Access to Judicial Information and Justice by Citizens," which is being developed by the International Development Research Centre (IDRC). Both contributed to the evaluation structure of the Index of Online Access to Judicial Information.

Ryan Lax of the University of Toronto, Canada, worked from May through July on the projects mentioned above for JSCA's Management Area. He focused on identifying specific experiences of Judicial Academies and the systematization of best practices in the implementation of ICTs in the justice sector. During this same period, **Herbert J. Rivera** of Georgetown University collaborated on Management Area projects such as the Index of Online Access to Judicial Information and the Impact of Information Technologies on Access to Judicial Information and Justice.

During the second stage of the development of the Index, interns **Rodrigo Velásquez**, who is Nicaraguan but is studying at Chile's Universidad de los Andes, and **Ignacio Alarcón**, a Chilean students from Universidad Alberto Hurtado, evaluated the institutional Websites of prosecution services and judicial branches of OAS member states.

Finally, between October and December, the Center hosted three students from American University, who took part in the project "Effective Justice: The Role of New Technologies in the Transformation of the Judicial System." The interns' names are **Megan Patterson**, **Kara Sparling** and **Susan Stine**.

Finally, **Natalie Reyes** of New York University is completing an internship at JSCA. She is contributing to projects and research related to pretrial detention and alternatives to it, and is providing support in the Management Area. She will continue at the Center through the end of 2010.

During the second semester of this year, JSCA signed an agreement with the University of Toronto for collaboration on Management Area projects, which will take place between October and December through distance learning and sharing technologies.

Impact:

The interns made valuable contributions to each of the studies (see www.cejamericas.org). When an intern finishes his or her program, they are given a survey regarding their experience at JSCA. All of the surveys applied this year indicate that the interns are 100% satisfied with their experience.

4.4 JSCA Virtual Information Center (VIC) and Virtual Library

Virtual Information Center (VIC)

Objectives:

JSCA's Website is its main vehicle for providing information and generating spaces for interaction among individuals and institutions interested in judicial reform issues at the regional level. Our goal is to continue to improve and expand the site throughout the year, increasing the services provided to our users, which include the virtual library, calendar, JSCA project and product information, course registration materials and access to virtual courses through CEJACAMPUS.

A total of 381,945 searches (through September 2010) were logged on the Website. Virtual products or platforms include the sites for the 6th Index of Online Access to Judicial Information, the VII Seminar on Judicial Management and the corresponding multimedia CDs.

This year, a new Joomla platform for www.cejamericas.org was developed.

JSCA Virtual Library

Objectives:

To provide information on justice reform and modernization processes at the regional and global levels and to provide spaces for dissemination and exchange. Specifically, the Virtual Library gathers and disseminates information of interest such as international and national laws; local, regional and global research studies; and articles through the institution's Website.

Impact:

During the first semester of 2010, the journal became virtual, which facilitates its distribution, lowers costs, and allow for more intense interaction among readers.



The most recent issue focuses on pretrial detention. A second 2010 issue, which is to be released in November, is centered on complex crimes. There will be a special section on judicial structure.

Objectives:

To promote the exchange of ideas and experiences with judicial reform processes in the region and generate a greater impact on new Internet users.

During the first semester of 2010, JSCA developed a Facebook presence that allowed it to disseminate the institution's news and share news from the justice sector. The platform currently has 2,200 members and is updated daily.

In June, we created a JSCA Twitter page that allows us to disseminate brief news messages. JSCA currently has 50 Twitter followers and 150 scribd followers.

Finally, the JSCA and Judicial News podcast platforms were developed during the second semester of 2010 to generate interview programs online. We have 17 podcasts and have had a total of 2,000 audio downloads.

Impact:

"VII Seminar on Judicial Management: Investing in Justice"

Published in March 2010. This publication features a collection of the presentations offered at the seminar, which was held in October 2009. A total of 1,000 print copies of the publication have been made available to date as well as a free PDF version, which has been published online.

The study on prosecution and investigation contains local reports on Argentina, Chile, Colombia, Mexico, Perú and Venezuela as well as a comparative introductory chapter. Published in November



2010. The final version of the report is in progress.

The issue on innovation that will be published in November 2010 features seven experiences presented in two sections. The first contains innovative experiences in the transformation of the criminal justice system including the introduction of a hearing management model in Guatemala, the reform process in Argentina's Chubut Province and the changes implemented in Buenos Aires. The second section has four papers that document innovative experiences outside of the criminal arena. The first describes the introduction of oral procedures in non-criminal cases in Costa Rica and the other three refer to recent reforms introduced in Chile. The first analyzes the operation of the new family courts in Santiago, the second focuses on the new labor justice model and the third analyzes the use of alternatives to pretrial detention in cases involving domestic violence.

A total of one thousand copies were printed, and the publication was posted on the JSCA Website, www.cejamericas.org.

"Introduction to Gender Issues in Criminal Justice in Latin America," a Spanish language publication issued in June, was updated and adapted to manual format by Chilean expert Lidia Casas. A group then shaped the Virtual Training Program of the same name, which JSCA has implemented twice.

The purpose of the effort is to identify aspects of criminal procedure in which gender issues become important, providing tools that help judicial actors to handle them in a manner that is in keeping with new demands.

II. INSTITUTIONAL SUSTAINBILITY

1. Financial Report

1.1. Income

Resources received and projected through December of this year total US\$1,331,290. This amount is 1% lower than the income reported for 2009. The table below presents information on income by type of source:

CIDA continues to be the most important source of cooperation project funding. New funding was obtained from Open Society, IDB, ICA, the World Bank and MSI.

There has been a 2% decrease in voluntary contributions due to the lower contribution received by the Government of Chile and the absence of contributions from other nations.

FIGURE No. 1 INCOME BY TYPE OF SOURCE 2008- 2009-2010





Figure No. 2 INCOME BY SOURCE 2007 – 2008-2009



Figure No. 2 COMPARISON OF SPENDING ON ACTIVITIES 2008-2009-2010






In 2010, most activates-related spending was related to training initiatives. There was a 2% increase over the previous year in activities.
