I. JUSTICE REFORM IN THE AMERICAS

1. General Promotion of Judicial Reforms in the Region

1.1. Inter-American Seminars

ENTRY 1/08

Second Inter-American Seminar on Civil Justice Reform

Objectives:

To generate regional discussion of the public policy lines that civil justice reform should follow in the region based on research performed by JSCA during 2007 and the contributions generated by the Group of Experts formed for this purpose. Participants also discussed ongoing initiatives in Europe and this region that could contribute to innovative solutions to problems in this area.

Location(s):

The seminar was held May 14 and 15 in Santiago de Chile and was attended by people from throughout the region.

After the event, papers selected for presentation through a regional competition were published in a Spanish-language book entitled "Civil Justice: Perspectives for Reform in Latin America." The monograph brings together experiences from countries in Latin America and Europe that have addressed changes in this area. The publication is available online at

Impact or Results:

The event was attended by 120 people from countries around the region including officials and members of justice sector institutions, many of them responsible for judicial management, from 21 countries.

A total of 2,000 copies of the publication have been distributed to over 600 people in the region. The book was presented on August 5 at a roundtable discussion in Santiago de Chile organized in collaboration with Americas Society and Council of the Americas and attended by 50 people.

ENTRY 2/08

VI International Seminar on Judicial Management "Progress and New Challenges in Judicial Management"

Objective:

To explore and analyze the progress that has been made in the areas of performance evaluation, the use of information for decision-making, the incorporation of Information and Communications Technologies (ICT) and administrative management of Supreme Courts in the region along with new challenges that have been introduced as a result of the introduction of high standards of ethics and transparency in jurisdictional labor from the perspective of its management.

A regional competition was held to select papers for presentation. The material was later compiled in a CD that was distributed to participants.

Impact or Results:

The event was attended by 120 people from around the region including high-ranking Peruvian judicial officials and their peers from other countries. The seminar was covered by several media outlets.

ENTRY 3/08

International Seminar "Challenges of Pretrial Custody in Criminal Procedure Reform: Evaluation and Perspective"

Objectives:

To discuss and analyze the impact that changes in criminal justice reforms have had on pretrial custody, paying special attention to the volume of use, conditions under which it is applied, and alternative measures that have been introduced in most countries in the region.

Seven local studies requested by JSCA (Bolivia, Chile, Colombia, Ecuador, Guatemala, Honduras and Venezuela) were presented and a comparative study was developed. The documents will be published in early.

Impact or Results:

The event was attended by 110 individuals from 10 countries around the region.

The day after the seminar, a closed workshop was held for 25 experts in the field from countries around the region. The purpose of this event was to discuss the specific steps to be taken and opportunities for intervening in the problem of the excessive use of pretrial custody. Participants represented the following countries: Argentina, Bolivia, Chile, Colombia, Costa Rica, Ecuador, Guatemala, Honduras, Mexico, Peru and the United States.



1.2. Research

ENTRY 4/08

Best Practices for the Investigation, Prosecution and Punishment of the Crimes of Homicide and Corruption in Countries of the Americas

Objectives:

To extend successful experiences in the region with the investigation, prosecution and punishment of the crimes of homicide and corruption, increasing the number of cases solved and the quality of the solutions applied. In order to achieve this, the project will provide tools—extracted from specific experiences—that will enable police agents and prosecutors to be more effective in the design and execution of activities aimed at investigating, prosecuting and punishing the crimes of homicide and corruption.

Countries covered in the study:

Three countries in the region.

Funding Source:

The Government of Italy and the Office of the Undersecretary of Political Affairs of the Organization of American States (OAS)

Products:

A proposal will be developed and the methodology designed will be utilized for the execution of this project.

Impact or Results:

Project approved and funded. It will continue during 2009.

ENTRY 5/08

Support for Haiti's Judicial System

Objectives

To develop a program to support justice in Haiti that contributes to generating openness in related sectors in order to consider the need and opportunities for introducing changes to the legislation and operation of the judicial system, which is facing diverse challenges.

Countries involved:

Haiti

Funding Source:

United Nations Development Program (UNDP)

Products:

Training for over 45 members of the Haitian legal community through the **Seminar on the Criminal Justice System and Rule of Law**, which was held October 6-10 in Port-au-Prince, Haiti. The seminar was attended by important local officials.

The course was composed of five modules that addressed the following topics: experiences in criminal justice reform in countries around the region; mutual legal assistance in criminal justice and international cooperation; management of legal information; protection of fundamental rights in rule of law; and judicial independence.

A group of French-speaking experts who are familiar with processes of judicial reform from Argentina, Bolivia, Canada, Chile, Costa Rica, the Dominican Republic and El Salvador participated in the event.

Impact or Results:



The event was covered by the local media.

It generated a request for coordination for a workshop on Knowledge of the Operation of Chile's Adversarial Criminal Justice System for a Haitian delegation. The activity will take place in January 2009 and will be coordinated by JSCA.

ENTRY 6/08

Program to Strengthen Justice in Panama

Objectives:

To support the planning and implementation of an adversarial criminal justice system in Panama.

Countries involved:

Panama

Funding Source:

EUROsociAL Justice Sector

Products:

The Project to Exchange Experiences for the Implementation of the Adversarial Criminal Justice System in the Judicial Branch of the Republic of Panama that is being implemented by EUROsociAL Justice and executed by JSCA and the Judicial Branches of Chile and Colombia. The project lasted for six months and included exploratory visits to Chile and Colombia in order to provide a more global analysis of criminal procedure systems that have been implemented in the region.

Specialists from Chile and Colombia and especially JSCA who formed part of the Joint Committee on Panama also made a four-month visit to train and advise the local group that was responsible for planning and implementing the adversarial system.

Impact or Results:

A proposal for implementation will be drafted and a Dissemination and Validation Seminar will be held in March 2009.

1.3. Other Activities

ENTRY 7/08

Inter-institutional Cooperation Agreements

Objectives:

To increase collaboration with government and civil society institutions linked to judicial systems in the region. Eight inter-institutional cooperation agreements were signed in 2008, which brought the total number signed since JSCA's inception to 73.

ENTRY 8/08

Pro Bono Internships

Objectives:

To enrich the work of JSCA through interns' new approaches. The goal is to create links with former pro bono interns in order to establish communications with local experts and institutions. This program is mainly aimed at students or recent graduates. It provides an opportunity to understand and take part in JSCA's work on judicial reform in Latin America.

Products:

During 2008, JSCA had six pro bono interns. Kimberly Polacek of American University and Amanda Wiss of Brooklyn Law School completed internships between April and July. They contributed to the effort to gather data for studies on the use of pretrial custody that were presented at the International Seminar "Challenges of Pretrial Custody in Criminal Procedure Reform: Evaluation and Perspective."

Kelechi Acholonu of Georgetown Law Center and Dana Brimmer of Harvard College also completed pro bono internships. Acholonu worked on the IV Index of Online Access to Judicial Information and Brimmer assisted on research on mutual legal assistance in transnational crime and worked on the virtual library.

Finally, Melissa Price, a law student at Berkeley, and Raúl Guillen, Universidad Nacional Autónoma de México, were part of the program. Ms. Price served as a pro bono intern from August to December and worked on research on pretrial custody and the Report on Judicial Systems in the Americas.

ENTRY 9/08

Paid Internships

Objectives:

To promote the exchange of experiences and create future links with local institutions and experts. The specific objective of this activity is for the intern to develop and acquire a broad set of skills and training that enrich his or her work as well as that of JSCA.

Throughout 2008, Pierre-Gilles Belanger, a senior intern at JSCA and representative of the Department of Justice of Canada, worked with the institution, supporting the development of actions in Haiti such as the seminar that was held in October.

2.1. Innovation Projects

ENTRY 10/08

Support for Processes of Criminal Procedure Innovation

Objectives:

To support the processes by which ideas and instruments designed to improve the operation of reformed criminal justice systems are adopted by the countries of the region. These activities come from direct requests from countries or governments and generally develop as a result of local replicas of the Inter-American Training Program. The support activities are very diverse in nature but generally involve training, support for design and supervision and, in more general terms, political support for the process.

Location:

Funding Source:

Impact or Results:

A study entitled "Criminal Procedure Reform in Ecuador: Experiences in Innovation," which describes initiatives for improving the criminal justice system that were implemented in Quito, Cuenca, Guayaquil and Azores. This is Volume V of the Follow-up Project on Criminal Procedure Reform in Latin America.

Two thousand copies of the document have been published and over one thousand of them have distributed locally and throughout the region. The study is also available on the JSCA Website www.cejamericas.org

ENTRY 11/08

Buenos Aires Province Project

Objectives:

To continue to support the implementation of oral procedures in the early stages of cases involving defendants who were caught committing a crime, extending their coverage to the entire province. This activity forms part of the Collaboration Agreement that JSCA signed with the Supreme Court, the Attorney General's Office and the Ministry of Justice. JSCA's contribution is focused on training, supervision and evaluation of experiences.

Products:

Several training activities were held during 2008 including:

Workshop to reinforce training on the procedure for cases in which the defendant was caught in the act in the judicial department of Bahía Blanca, held April 28 in that city. The event was attended by 31 officials and judges.

Workshop to reinforce training on the procedure for cases in which the defendant was caught in the act in the judicial department of Morón, held May 6 in that city. The event was attended by 35 people, including officials and judges from Morón.

Course on New Procedure for Cases in which the Defendant Was Caught in the Act: The Use of Oral Procedures at the Guarantee Stage. La Plata, November 26. The target audience included judges from guarantee courts, public defenders and prosecutors from the judicial departments of Azul, San Nicolás and La Plata. An estimated 25 people attended the course.

Course on New Procedure for Cases in which the Defendant Was Caught in the Act: The Use of Oral Procedures at the Guarantee Stage. La Plata, June 27. The target audience included judges from guarantee courts, public defenders and prosecutors from the judicial departments of Quilmes and Dolores. An estimated 45 people attended the course.

Impact or Results:

The participants went on to provide training in their local areas.

2.2. Research

ENTRY 12/08

Challenges of the Use of Pretrial Custody in Criminal Procedure Reform

Objectives:

To allow JSCA consultants to develop unpublished local reports and products on the current use of pretrial custody that were presented at the International seminar on this topic that was held on November 28.

Location:

Regional activity

Funding Source:

Open Society; CIDA

Date:

Throughout 2008

Products:

Seven country studies (on Bolivia, Chile, Colombia, Ecuador, Guatemala, Honduras and Venezuela) and a comparative report were developed at JSCA's request.



Impact or Results:

The documents were presented at the International Seminar on this topic that was held in November in Bogotá, Colombia.

They will be published in early 2009.

ENTRY 13/08

Monitoring Criminal Procedure Reform: Research, Publication and Dissemination

Objectives:

To explore the results and impact of criminal justice reform processes in the region. These studies form part of the work that JSCA has done in 12 countries in the region and are geared towards generating empirical data on the progress achieved and obstacles encountered.

Location:

The first study was developed in the Province of Buenos Aires, Argentina. Its purpose was the complete the work done in 2006 on the pilot project in Mar del Plata that now covers four judicial departments.

The second was developed in Peru and covers the results achieved during the first year of the reform in the La Libertad (Trujillo) judicial district.

Funding Source:

Products:

The studies will be published in early 2009 as part of a collection focused on Monitoring Criminal Procedure Reforms.

Impact or Results:

The Peru study was presented in December in Lima and Trujillo in collaboration with the Supreme Court at discussions with the institutions involved. Over 50 people attended each session. Several meetings were held between technical teams from justice institutions and JSCA experts.

ENTRY 14/08

Report on Mexico's Criminal Justice System

Objectives:

To assist Mexico, which is involved in a constitutional reform designed to install an adversarial system at the federal level. The Supreme Court requested JSCA's assistance in order to develop an evaluation of the current criminal justice system at the federal level and in three states. The purpose of the effort is to detect the contents and challenges that will be involved with changing the current system to an adversarial one.

Location:

Mexico, at the federal level and in three states

Funding Source:

Supreme Court of Mexico

Products:

An evaluation of the current federal criminal justice system followed by a report that contrasts the current system with a modern oral and adversarial one.

Impact or Results:

The results will be published in early 2009.

2.3. Training



ENTRY 15/08

V Inter-American Program for Training Trainers for Criminal Procedure Reform

Objectives:

To improve the results of criminal justice reform processes around the region by training actors and leaders and holding replicas of JSCA's training program in their countries. The program involves three stages: a basic course offered on site; an e-learning course offered through CEJACAMPUS; and a final meeting in the city of Santiago de Chile.

Locations:

The first phase, "Instruments for Implementing an Oral and Adversarial System," was held in Reñaca May 5-9. The third phase took place in Santiago, running the week of November 24.

Funding Source:

Products:

Training materials for the program. Two on site courses and a virtual course. Improvement of the CEJACAMPUS Website.

Impact or Results:

The program was very well-received throughout the region. A total of 213 people from 17 countries applied, and 58 were selected to participate. The following countries were represented in the student body: Argentina, Bolivia, Brazil, Chile, Colombia, Costa Rica, the Dominican Republic, Ecuador, Honduras, Mexico, Nicaragua, Panama, Peru and Uruguay.

ENTRY 16/08

II Meeting of Inter-American Training Program Alumni

Objectives:

To strengthen the alumni network in order to broaden members' knowledge of issues related to the implementation of innovative initiatives in regional reform processes and to strengthen joint efforts among members.

The seminar on Challenges of Criminal Procedure Reform and Public Safety featured discussions of innovative initiatives in regional reform processes. ENTRY 23/08

Visits / Workshops on Criminal Justice in Chile

Objectives

To allow foreign delegations to learn about Chile's criminal procedure reform and understand its judicial and administrative logics and dynamics as well as matters of implementation and management. This is executed through guided visits to observe hearings and administrative processes and meetings with reformers and JSCA staff members.

Location:

Metropolitan Region of Santiago de Chile

Funding Source:

The delegations cover their own costs.

Products:

The following visits were held in 2008:

- Visit by the delegation of the Temporary Public Defense Unit of Ecuador (February 15). Participants learned about the Public Defender's Office and Chile's reform.
- Visit by the delegation of the Magistrate's Council of the City of Buenos Aires (January 7-11). This delegation of eight prosecutors and one judge traveled to Chile in order to learn more about the operation of the country's criminal procedure reform. They visited the Santiago Justice Center, met with Regional Public Defender Leonardo Moreno, observed hearings and toured special units within the Public Prosecutor's Office.
- Visit by the delegation from the Dominican Republic (January 18). A delegation of five attorneys learned about JSCA's work and its role in the region.
- Visit by the National Public Defender's Office of Peru (January 21-25). Four officials from the Peruvian Ministry of Justice visited JSCA in the company of the former National Public Defender of Chile, Rodrigo Quintana. Participants learned about the structure, operation and work of the Chilean public defense service. They visited the National Public Defender's Office, two regional public defender's offices in Santiago, the Valparaíso Public Defender's Office and the Chilean State Defense Council. JSCA's Academic Director offered a presentation on criminal procedure reform in Chile at our headquarters.
- Visit by representatives of the Hague International Law Conference (April 25). The JSCA Training Area received two representatives from this entity. A Training Area assistant offered a



presentation on JSCA's activities and structure and described our training activities.

- Visit by the delegation from Panama (September 1-5). JSCA and the EUROsociAL Justice Project held a visit designed to provide 10 people from Panama (specifically, 7 judicial officials, two prosecutors and one public defender) with information on Chile's criminal procedure reform. The visit included meetings with operators from many areas of the Chilean criminal justice system as well as lectures on criminal procedure reform and the role of management in reformed institutions by Mauricio Duce, Cristián Hernández and Adrián Medrano.
- Visit by members of Argentina's Magistrates Federation and Unidos por la Justicia (October 6-8). A delegation of 15 people including officials and judges from around the country learned about the development of Chile's criminal procedure reform, its judicial and administrative dynamics and matters of implementation and management.
- Visit by the Peruvian delegation (October 13-16). A delegation of 14 people from Lambayeque, Peru visited our headquarters. The group was led by the Chief Justice of that judicial district.

Debt Recovery and Sentence Execution Procedures in Europe

Objectives:

To describe the main components of public policies on debt recovery and sentence execution procedures which have been implemented in European countries. This is an initial descriptive approach to the topic designed to present the main elements and contribute to regional discussions in the Americas.

Bases for Civil Justice Reform

Objectives:

To develop a document that serves as a guide for countries that are interested in undertaking civil



justice reform processes. This document will provide specific recommendations on the contents of these reforms in such areas as small claims justice, monetary debt recovery, bankruptcy, oral trial, procedural resources and sentence execution. It also presents proposals for strategies for handling the reform process and financing of the same.

Impact or Results:


The Website received a total of **96,747** visits last year.

During the first quarter, the new version of Nexus Newsletter was launched. This publication is more



compact and offers a link to a page that provides more information on each topic. The products for this area include the fourth version of the Index to Online Access to Judicial Information and a multimedia CD.

The Virtual Information Center was restructured in August and the Website maintenance services were outsourced. The site has a new host as of mid-December.



E-learning Platform

There was a great deal of activity on this platform during 2008, including the Inter-American Training Program and "Challenges to the Public Prosecutor's Office and Criminal Prosecution in Latin America," a four-module virtual course that was completed by over 60 people.

ENTRY 32/08

JSCA Virtual Library

Objectives:

To provide information on reform and modernization processes in the area of global and regional justice to the interested community in the Americas and to offer spaces for disseminating and exchanging said data. Specifically, to gather, integrate and disseminate information of interest including national, international, regional and local legislation and articles through the Center's Website.

Products:

Last year we contacted justice system institutions in order to strengthen links through the Virtual Library. We continued to promote the tool for uploading documents that was developed in 2006 in order to allow users to add their information to our site (subject to staff approval).

Impact or Results:

A total of 105,360 searches were completed in our Virtual Library, which holds documents on justice in the Americas. 401 new virtual documents in Spanish and English were added to the collection, including studies, articles, reports and legislation.

This year JSCA's physical library donated publications to many institutions, including: Universidad Mayor, Universidad Católica del Norte, Universidad de Concepción, Universidad de Miguel de Cervantes, Universidad de Humanismo Cristiano, Universidad Católica de Valparaíso, Universidad de Viña del Mar, Universidad Santo Tomás, Universidad de Miguel de Cervantes, Universidad Internacional SEK, Pontificia Univ. Católica de Chile, Universidad ARCIS, Universidad de los Andes



and Universidad de Chile.

429 new titles were added to the physical library in the form of journals and CDs. This represents an 8% increase over the previous year, bringing the collection to 2,676 titles.

II. INSTITUTIONAL SUSTAINABILITY

2. Financial Report

2.1. Income

JSCA's income through December was US\$1,699,185. This is 7% lower than the institution's income from 2007. This is mainly due to a decrease in USAID project contributions.

Income from contribution projects has remained the main source of funding. It is important to note that contribution projects have decreased in their relative importance as compared to the total income, from 71% to 62%. Other sources of income have increased from 16% to 21%.

Voluntary contributions increased by 2%. Contributions from the Governments of Chile, Mexico and China remained unchanged.

FIGURE 1 COMPARISON OF INCOME BY TYPE OF SOURCE 2006 – 2007- 2008





FIGURE 2 COMPARISON OF INCOME BY SOURCE 2006 – 2007 – 2008





2.2 SPENDING

Spending for 2008 totaled US\$1,461,000. This represents a 6.6% decrease as compared to the previous year. Table 2 presents a detailed list of expenditures for 2008.

FIGURE 2 COMPARISON OF SPENDING ON ACTIVITIES 2006 – 2007-2008




III. BALANCE

In summary, in 2008 the institution generated had income (US\$1,699,185) than it did expenditures (US\$1,461,000), which produced a surplus of US\$238,185.
